The State contracts with twenty Community Centered Boards to deliver community-based services. Each CCB has a non-overlapping geographic service region of one to ten counties serving from 70 to 1,600 individuals each. CCBs are responsible for intake, eligibility determination, service plan development, arrangement for services, delivery of services (either directly and/or through purchase), monitoring, and many other functions.</p>
